2. OVERVIEW/EXECUTIVE SUMMARY

2.1 How Carbon Neutrality Links to our Mandate

Carbon Neutrality is considered an integral component of sustainable environmental practices and education curriculum. The School District 72 Strategic Plan articulates the importance of environmental sustainability to our organization:

Strategic Focus 3 - An Expanded and Purposeful Environmental Ethic

What happens in our classrooms every day shapes future generations. As an educational organization, we must ensure by policy and action that environmental stewardship is an important theme in every school. We will continue to raise environmental awareness, implement "green" projects and initiatives, and encourage environmentally sustainable behaviours.

An example of the link between environmental sustainability and education curriculum is the BC Hydro and School District 72 partnership providing unique educational opportunities for teachers and students during the five-year construction period of the John Hart Generating Station Replacement Project. Students ranging from Kindergarten to High School will explore the importance of the Campbell River watershed from an economic, cultural, ecological and recreational perspective and, in the context of greenhouse gas emissions, investigate how electricity and hydroelectric power generation shape a community.

2.2 Broader Sustainability Goals of School District 72

School District No. 72 (Campbell River) adopted the following Environment Responsibility Policy B-15 on June 23, 2009.

The Board of Education has a responsibility towards sustainable environmental stewardship.

The Board of Education is committed to raising environmental awareness of all staff, students, trustees and the community by delivering effective environmental education and modeling environmentally responsible practices (with respect to wise water use, energy-use reduction and waste minimization). The Board will endeayour to:

- Provide teachers with environmental education resources
- Align what is taught in the classrooms with school operations (curriculum, transportation and facilities)
- Reduce its impact on the environment
- Recognize successful environmental initiatives and programs.

The Board of Education expects that:

- The School district will consistently consider the impact of the environment of decisions that are made in the delivery of curriculum and in daily operations
- Schools will integrate environmental education and environmentally responsible action within the school setting.

The Board of Education authorizes the establishment of an Environmental Awareness Focus Group, which will set goals in relations to

- Environmental education
- Effective implementation of sustainable environmental practices

Ongoing measurement and evaluation of environmental performance.

Definitions

"Environment" is the surroundings in which an organization operates including air, water, land, natural resources, flora, fauna, humans and their inter-relations.

"Environmental Education" refers to organized efforts to teach about how natural environments function and, particularly, how human beings can manage their behaviour and ecosystems in order to live sustainably. Although the term is often used to imply education within the school system, from primary to post-secondary, it is sometimes used more broadly to include all efforts to educate the public and other audiences, including the use of print materials, websites, media campaigns, etc. Related disciplines include outdoor education and experiential education.

"Impacts on the environment" are any changes to the environment whether adverse or beneficial, wholly or partially resulting from an organization's products or services.

"Sustainable means practices that serve to meet the needs of the present without compromising the ability of future generations to meet their own needs.

"Stewardship" is the act of caring for something that one doesn't own.

2.3 Benefits of Reducing Energy use and GHG emissions

Since 2009, School District 72 has reduced its total energy consumption by 16.2%. As illustrated in the following table, the cumulative avoided costs of \$254,000 achieved over the past four years have mitigated the impact of increasing utility rates.

School District 72's achievement in energy savings is more apparent when considered in terms of energy intensity, which reflects changes in amount of building inventory under management. Our organization has reduced its energy intensity by 28.6% since 2009.

Greenhouse gas emissions have also decreased since 2009. Over the past four years, cumulative avoided costs of \$17,075 have been achieved in the purchase of carbon offset payments.
