Declaration statement: This Climate Change Accountability Report for the period January 1, 2020 to December 31, 2020 summarizes our emissions profile, the total offsets to reach net-zero emissions, the actions we have taken in 2020 to reduce our greenhouse gas emissions and our plans to continue reducing emissions in 2021 and beyond.

Overview:

Actions taken in 2020 to minimize emissions included the following facility upgrades:

- a. Quadra Elementary life cycle replacement of six roof sections included increasing the roof R-value and use of a reflectivity coating
- b. Timberline Secondary life cycle replacement of four roof sections included increasing the roof R-value and use of a reflectivity coating
- c. Ecole Willow Point life cycle replacement of boilers included conversion to high efficiency boilers
- d. Southgate Middle replacement of gym unit ventilators and upgrade of heating controls
