# MINUTES OF A MEETING OF THE BOARD OF EDUCATION OF SCHOOL DISTRICT NO. 72 (CAMPBELL RIVER), HELD IN PERSON AND ELECTRONICALLY AT 7:30 PM, ON TUESDAY, NOVEMBER 26, 2024

#### 24-185 Call to order/chair's remarks

Board Chair Eddy called the meeting to order at 7:30 pm. Eddy began by addressing the fire at Carihi Secondary School on November 21, 2024 and acknowledging the response efforts. She thanked the district's compassionate response team, who supported students, staff and families from Friday through Monday, as well as the maintenance and operations staff for their quick work in cleaning and assessing the school. Special thanks were also given to the senior leadership team and to the communications manager for keeping the community informed. Eddy expressed gratitude to the many firefighters from various areas who worked to contain the fire.

She closed by highlighting the trustees' participation in the BCSTA Trustee Academy, held Nov 21-23, 2024, where they learned about gathering student input and supporting inclusion and diversity.

#### 24-186 Superintendent's remarks

Superintendent Manning expressed his gratitude to the community, provincial partners, and Carihi staff for their efforts during the fire response, commending their planning to prioritize students' needs. All students will be back in school on December 2, 2024 with Oyster River school secured as the satellite space. A big thank you to everyone who worked diligently behind the scenes.

The marking for the Fundamental Skills Assessment (FSA) for grades 4 and 7 is complete, and the results will be shared with the board soon.

At the BCSTA Trustee Academy, the focus was on inclusion. Campbell River School District teaching staff member Natalie Raedwulf-Pogue shared an outstanding presentation. Additionally, Audrey Wilson received the BC Principal Award at BCSTA for her excellent work in the community working with children.

## 24-195 November 21-23, 2024 BC School Trustee Association (BCSTA) Trustee Academy

Trustee Gillis reported that it was an honour to attend the Trustee Academy with 59 other school districts, and everyone agreed it was the best event they've attended. Trustee Gillis expressed gratitude to the many districts that reached out offering support regarding the Carihi fire. Additionally, Trustee Gillis attended a 3-hour session on AI, where he learned how AI can be used effectively in education.

## 24-196 November 23, 2024 Vancouver Island School Trustees Association (VISTA)

Board Chair Eddy confirmed that SD72 Trustees will be hosting the 2025 VISTA fall annual meeting in Campbell River. SD72 Trustees brought forward two motions through VISTA for consideration at the BCSTA AGM in April 2025, both of which were approved. These motions focus on a cybersecurity initiative and the creation of a new funding stream, an Annual Technology Grant (ATG), to fund instructional technology and ensure equitable access to instructional technology across the province.
