MINUTES OF A MEETING OF THE BOARD OF EDUCATION OF SCHOOL DISTRICT NO. 72 (CAMPBELL RIVER), HELD IN PERSON AND ELECTRONICALLY AT 7:30 PM, ON TUESDAY, November 4, 2025

Present C. Gillis, Vice-Chair; S, Briggs, J. Gladish, D. Hagen, D. Harper, J. McMann Trustees; P. Cizmic, Associate Superintendent, G. Manning, Superintendent; and K. Patrick Secretary-Treasurer.

Absent: K. Eddy, Trustee

25-158 Call to order by Secretary Treasurer

Secretary Treasurer Patrick called the meeting to order at 7:30 pm. Patrick called the Board's attention to *Board Governance Policy 15: Meetings, (1.6)* which notes: "In non-election years, at the first public board meeting in November, the chair and vice-chair shall be elected, and signing officers shall be appointed".

25-159 Election of Chairperson for the Board for the period November 4, 2025-November 3, 2026.

Secretary-Treasurer Patrick took the Chair for the purpose of calling for nominations and electing a Board Chair for the period November 4, 2025-November 3, 2026.

Trustee McMann nominated Vice-Chair Gillis, for the position of Chair. Gillis accepted the nomination.

After calling two more times for further nominations and hearing none, Secretary-Treasurer Patrick declared that Craig Gillis was elected Board Chair by acclamation for the upcoming year.

25-160 Election of Vice-Chairperson for the Board for the period November 4, 2025-November 3, 2026

Board Chair Gillis took the Chair for the purpose of calling for nominations and electing a Board Vice-Chair for the period November 4, 2025-November 3, 2026.

Trustee Gladish nominated Trustee McMann for the position of Vice-Chair. McMann accepted the nomination.

After calling two more times for further nominations and hearing none, Board Chair Gillis declared that Joyce McMann was elected Board Vice-Chair by acclamation for the upcoming year.

25-161 Chair's Remarks

Gillis also commented on the dedication of long serving staff members who will be recognized on November 18 and the contributions of volunteer coaches.

Chair Gillis attended the virtual meeting of the BC School Trustees Association Provincial Council meeting on Oct 24, 2025. Discussion centred on advocacy goals for the association and preparation for the BC School Trustees Association Trustee Academy in November.

25-171 October 28, 2025 City of Campbell River/ SD72 liaison committee meeting

Chair Gillis noted discussions at the Oct 28, 2025 City of Campbell River/ SD72 liaison committee meeting that touched on: feedback on city managed dog parks on school property; community concerns and initiatives and other projects of mutual interest including the City's master transportation plan, child care facility construction and the restart of the Ishikari- Campbell River exchange program.

25-172 October 22, 2025 BC School Trustees Association Indigenous Education Advisory Committee meeting

Trustee Gladish shared her report on the virtual BC School Trustees Association Indigenous Education Advisory Committee meeting she attended on October 22, 2025. Committee members praised the panel presentation at the Vancouver Island School Trustees Association fall conference held in Campbell River Oct 3-4. At the IEAC meeting committee members also discussed the United Nations Declaration on the Rights on Indigenous Persons (UNDRIP) and the First Nations Education Steering Committee's (FNESC) student attendance initiative.

25-173 November 3, 2025 Human early learning partnership webinar

Vice Chair McMann joined the Human Early Learning Partnership webinar hosted by UBC on November 3, 2025. The partnership gathers data and reports on overall provincial trends in children's development to gain a deeper understanding of children's social and emotional health and well-being during early and middle childhood, from their own perspective
